

### Request Requirements

- The Federal Home Loan Bank of San Francisco ("Bank") is accepting Tribal Nations Program Grant disbursement requests on a first-come, first-served basis through Friday, November 13, 2026, or until program funds are exhausted, whichever is earlier.
- Grant Recipients must be Native American / American Indian organizations (includes tribal governments, tribal housing authorities and departments, and Native American / American Indian nonprofit organizations).
- Grant purpose must be related to affordable housing development for low- to middle- income households or individuals from 0% to 140% of Department of Housing and Urban Development (HUD) Area Median Income (AMI), which can include the following:
  - Predevelopment / infrastructure work and related needs assessments / reports / property acquisition (includes *but is not limited to* roads, water, waste management, electricity, broadband, architecture and engineering, and environmental work).
  - Housing construction or rehabilitation and related needs assessments / reports (includes *but is not limited to* capital needs assessments, surveying housing needs for number of units, housing types, and household demographics)
- Grant Recipient must provide a balanced project budget for the grant's purpose showing funding sources and uses.
- The maximum grant amount is \$800,000 per Grant Recipient.
- Total Grant Requested must be greater than or equal to \$50,000 and must be in increments of \$10,000, up to the maximum grant amount.

Authorization

The Member hereby agrees to disburse the Grant to the Grant Recipient within thirty (30) days of receipt of the funds from the Bank and provide evidence, upon request, satisfactory to the Bank in its sole discretion, of such disbursements. If the Grant is not disbursed to the Grant Recipient within this deadline, the Member will return the Grant to the Bank within fifteen (15) days after the deadline.
